

ACKNOWLEDGMENT AND RELEASE

On this date below, the undersigned applied for and received a permit to operate a vehicle upon the beaches of the Town of Riverhead.

In consideration of that permit under Section 48-7 of the Code of the Town of Riverhead, the undersigned acknowledges that he/she has read, is familiar with, fully understands Chapter 48 of the Code of the Town of Riverhead and will abide by all the restrictions, limitations, rules and regulations contained therein.

In particular the undersigned acknowledges that he/she may not operate said vehicle upon any area of the beach lying above the mean high water mark. The undersigned acknowledges that he/she states that he/she has been advised and understands that the Sound Beach is defined in Chapter 48 of the Code of the Town of Riverhead as follows:

"Sound Beach - All that area in or adjacent to the Town of Riverhead along the shore of the Long Island Sound <u>lying between the mean high-water mark as a southerly boundary and the low-water mark as the northerly boundary."</u>

Further, the undersigned acknowledges that he/she states that he/she has been advised and understands that the following restrictions apply to operation of vehicle on a Town Beach.

"No motor vehicle may be operated upon the beach between May 15 and September 15, both inclusive, in each year except between the hours of 6:00 p.m. and 9:00 a.m., except as herein provided and except that motor vehicles may operate in the area approximately 2 1/4 miles east of Roanoke Landing to Reeves Cove at Reeves Farm at any time for the purpose of sport fishing only."

"No motor vehicle may be operated on the beach at any time unless same is duly registered by a State Motor Vehicle Bureau."

"No motor vehicle may be operated upon the beach at any time by a person who is not duly licensed to operate a motor vehicle by a State Motor Vehicle Bureau."

"No motor vehicle may be operated upon the beach at any time by any person unless a permit has been issued by the Town of Riverhead for such use pursuant to Town Code section 48-7.".

"No motor vehicle may be operated upon the beach by any person unless the motor vehicle is insured under a valid automobile liability insurance policy carrying the limits of at least \$10,000/\$20,000."

"No motor vehicles may be operated on the shores of the Peconic Bay beaches at any time."

In addition to any other penalties as provided under Town Code Chapter 48, the undersigned acknowledges that violation of any of the aforementioned restrictions or any other provisions of Chapter 48 may result in the revocation of the permit issued to the undersigned.

The applicant agrees to indemnify and hold the Town of Riverhead and their respective officers, employees, agents, representatives and officials from any and all loss or liability associated with the operation of the vehicle upon the Town of Riverhead Beach and related actions described herein, including liability for damages to property or for injuries or death to persons which may arise from, or be attributable or incident to the use by applicant, its family members, its employees, agents, representatives and concessionaires.
