## CAMP REGISTRATION FOR THE 2025 SEASON IS OPEN!

### Important Dates:

- **Monday, April 7th:** returning campers residing in the Town of Riverhead, and campers who attend the Riverhead School District, including new siblings entering the program
- **Monday, April 28th:** new resident campers and returning non-residents
- **Monday, May 5th:** all remaining campers, including new non-residents

### Upon registration, please provide the following information:

- Summer Recreation and/or Teen Camp Registration Form
- Updated physical and immunizations
- Emergency Card due by your camper's 1<sup>st</sup> day of camp
- Payment in the form of a check, cash, or credit (3.5% service charge applied to card)
- Epi-Pen and Self-Administered Inhaler Med. form signed by Physician's office (available upon request)

Registration paperwork will be processed in order of receipt. A payment receipt will be sent to you once your registration is processed. Checks can be made payable to Riverhead Recreation.

Teen Camp will be held M-TH at the TBD School location for children entering grades 7-8. Early Morning Care is available at both sites from 7:30am-8:45am.
